**AN ORDINANCE OF THE CITY OF O'FALLON, MISSOURI, AMENDING SECTION 500.200 OF THE MUNICIPAL CODE FOR THE PURPOSE OF DELETING PROVISIONS OF THE 2008 EDITION OF THE NATIONAL ELECTRIC CODE RELATING TO TAMPER-RESISTANT RECEPTACLES IN DWELLING UNITS.**

**WHEREAS**, with the passage of Ordinance 5670 on February 10, 2011, the City of O'Fallon adopted the 2008 Edition of the National Electric Code, including certain amendments thereto; and

**WHEREAS**, the City wishes to further amend the code so adopted by eliminating a provision therein requiring tamper-resistant receptacles because the Mayor and Council do not believe the requirement is necessary or economically prudent;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:**

**Section 1.**

Section 500.200 of Chapter 500 of the Title V of the Municipal Code of the City of O'Fallon, Missouri, as enacted by Ordinance 5670 on February 10, 2011, is hereby repealed and a new Section 500.200 is hereby enacted in lieu thereof to read as follows:

<b>Section 500.200:</b>	<b>ADDITIONS, INSERTIONS AND CHANGES</b>

The following sections of the Electric Code adopted in Section 500.190, are hereby revised:

- A. Section 406.11 Tamper-Resistant Receptacles in Dwelling Units: Delete in its entirety.
- B. Add Article: Article 90.1E Licensing of Electrical Contractors: Any contractor wishing to enter into the electrical business within the City of O'Fallon shall first be duly examined and be successfully passed and

licensed by the Board of Electrical Examiners of St. Louis County or St. Charles County, Missouri.

**Section 2.**

This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.


