

## CART PLACEMENT/LOADING REQUIREMENTS

Place all waste in a City-provided cart with the lid closed. All waste must be within the container or it will not be picked up. When placing your carts at the curb for collection, please be sure to place the carts so they are:

- On the side of your driveway opposite your mailbox
- As close to the street as possible (without being in the street)
- With handle facing towards the house and away from the street.
- On collection days, please do not park your car within four (4) feet of your cart or your neighbor's cart.

**ALL CARTS SHOULD BE SET AT THE CURB  
BY 6:30 AM ON THE COLLECTION DAY**

## REFUSE

Refuse is the solid waste resulting from day-to-day activities in, and maintenance of, a dwelling unit. All refuse set out for collection must comply with the following:

- By law, only non-hazardous solid waste can be collected.
- Waste which has reactive, corrosive, ignitable or toxic properties cannot be disposed of with your household refuse.
- Refuse mixed with yard waste cannot be collected, as it has been banned from landfills.
- By law, liquid wastes cannot be collected.
- Non-hazardous liquids, such as paint, may be mixed with an absorbent such as Kitty Litter, but it must be completely dry prior to collection. (*latex paint only*)
- Hazardous liquids, such as gasoline, motor oil or muriatic acid (chemical used to clean swimming pools), should be taken to a facility/processor capable of handling these types of materials. Please contact St. Charles County Division of Environmental Services (Recycle Works) at 636-949-7415 for more information.
- “Sharps” such as syringes or lancets must be contained in rigid containers such as detergent or empty bleach bottles or specialized containers available at pharmacies. Please do not use coffee cans, milk jugs or glass containers.

## RECYCLING

The following items are accepted under the recycling program. The City of O’Fallon’s recycling system allows containers to be collected curbside in your recycling cart. Paper and cardboard, although recyclable, can not be collected curbside. They must be taken to our Environmental Services Building at 1550 Progress West Lane, O’Fallon, MO 63366.

### Containers:

- Aluminum cans, steel cans and tin cans.
- Glass bottles and jars (no window glass, dinnerware or ceramics).
- **#1 Plastic** – Soda, water and flavored beverage bottles.
- **#2 Plastic** – Milk, juice, detergent/fabric softener jugs.
- **#3 Plastic** – Health/beauty aid products and household cleaners.
- **#5 Plastic** – Grocery containers (yogurt cups syrup/ketchup bottles).
- **#7 Plastic** – Containers only.

### Notes pertaining to containers:

- No #4, #6 or black plastics, please!
- All containers must be *EMPTY, CLEAN* and *DRY*. Labels do not need to be removed, and lids may remain on the items.
- No motor oil, insecticide, herbicide or hazardous chemical containers.
- Plastic bags should be returned to grocery/department store for recycling.

- No plastic film (no plastic sheets, tarps or wrap).
- No expanded foam (Styrofoam) or clear polystyrene.

**Corrugated cardboard and paper fiber may be recycled, but may not be recycled curbside. These items include:**

- Newspapers, ads/inserts, junk mail envelopes, magazines, catalogs, phone books and brown paper (Kraft) bags.
- Corrugated cardboard, chipboard (cereal/cake/food mix boxes, gift boxes, etc.) and carrier stock (soda and beer can carrying cases).
- Office/computer paper (no metal clips, spirals, binders).
- Paperback books (no hard cover books).

## ELECTRONICS/APPLIANCE RECYCLING DROP OFF

Recycle just about any item with an electrical cord or battery, including household appliances, water heaters, furnaces, HVAC, microwaves, computers, monitors (including CRTs), DVDs, cell phones, radios, stereos, power tools, lawn and garden equipment (gas and oil must be removed) and LED/LCD TVs. A fee will be charged for each cathode ray tube (CRT) TV set (see [www.ofallon.mo.us/ES](http://www.ofallon.mo.us/ES)). Please do not bring: smoke detectors, glass lamps, light bulbs, VHS tapes or alkaline batteries. The 2018 electronics recycling drop-off days will be held 8 a.m. – Noon at CarShield Field west parking lot (off Tom Ginnever Ave.) on:

Sat., April 14	Sat., Aug. 11	Sat., Dec. 8

This free, bi-monthly service is provided by the City of O’Fallon in partnership with Midwest Recycling Center.

## BULK WASTE

Bulk waste is defined as items which cannot fit fully within your refuse toter (excluding yard waste). O’Fallon offers curbside collection of bulk waste (for a fee). All items are not to exceed 6 feet length x 3 feet width x 3 feet height. To schedule a Bulk Waste collection, please call 636-272-0477. We also offer a complimentary bi-monthly Bulk Drop Off between 7 a.m. and 3 p.m. at our Trash Transfer Station at 1572 Progress West Lane, O’Fallon, MO, 63366, on the following dates:

## YARD WASTE

**O’Fallon Environmental Services customers may choose the yard waste service option that works best for them:**

- **Year-round pick up option featuring weekly service March to December and monthly winter service:** With this optional service, residents receive yard waste service once per week from the 2nd Monday in March through the 2nd Friday in December. Once a month service is offered on the 4th Wednesday of the month in December, January and February, which must be scheduled in advance.

The cost is \$5.62 per month (\$11.25 for bi-monthly bill) and is billed throughout the year. *A 1-year commitment is required.* Service is the same day as recycling, but there will be two separate trucks picking up your yard waste and recycling.

**Please note:** Twice a year, residents enrolled in the year-round yard waste service may request collection for up to twice as many units as guidelines allow, or up to 20 units (of bags, yard waste receptacles or bundles) instead of ten.

- **Free twice-a-year service:** Twice a year, residents enrolled in the City’s trash and recycling service, but who do not have year-round service may call in a request to customer service for free yard waste collection for up to 10 units. A unit is one yard waste bag, or one yard waste container or one bundle of sticks and limbs. After the two free collections are logged, if additional collection is needed the customer has the option of enrolling in yard waste service or requesting a one-time pick-up at \$2 per bag at a minimum charge of \$20.
- **Drop off:** Hansen’s Environmental Wood Resources will accept yard waste from residents of the City of O’Fallon for a fee. Please call Hansen’s directly at 636-379-1830 to schedule a drop-off and bring in a photo ID with your O’Fallon address.

Yard waste includes leaves, grass clippings, limbs and small branches. Yard waste may be disposed of in any of the following methods, but with no more than 10 of these combined:

- Resident-owned refuse container
- 30-gallon kraft paper yard waste bags (*no plastic bags*)
- Limbs/branches: 6 inches or less in diameter, four (4) feet or less in length, bundled in twine (*no wire*). Bundles not to exceed two (2) feet in diameter.
- Each individual unit may not exceed 60 lbs.

Yard waste DOES NOT include dirt, sod, rock, concrete, asphalt, lumber, tree stumps or logs over 6 inches in diameter. No pet/animal feces can be included in yard waste.
